Hon'ble Justice Kurian Joseph is a former Judge of the Supreme Court of India, where he served from 8th March 2013 until his retirement on 30th November 2018. He began his legal practice in 1979 in the High Court of Kerala and was appointed as Government Pleader in 1987, Additional Advocate General from 1994 to 1996, and was designated as a Senior Advocate in 1996.

He was elevated as a Judge of the High Court of Kerala on 12th July 2000. Over the course of his tenure, he held several distinguished positions including President of the Kerala Judicial Academy (2006–08), Chairman of the Lakshadweep Legal Services Authority (2008), Chairman of the Kerala High Court Legal Services Committee (2006–09), Executive Chairman of the Kerala State Legal Services Authority (2009–10), and Visitor of the National University of Advanced Legal Studies, Kochi (2009–10).

He twice served as the Acting Chief Justice of the High Court of Kerala before being appointed as Chief Justice of the Himachal Pradesh High Court, where he served from 8th February 2010 to 7th March 2013. His judicial career culminated in his elevation to the Supreme Court of India on 8th March 2013.
